- The town centre has a mix of national and independent retailers.
- The subject property is located on the eastern side of Melbourne Street, opposite the junction to Castle Street and within the prime pitch. Nearby retailers include Home Bargains, William Hill, David Pluck Betting, and Greggs.
- The property is not listed but it does fall withing the Tameside conservation area.
- The premises are currently arranged over ground, basement and 2 upper floors.


